#### **STORAGE:**

**INNOKOAT MSK-CARE (A5dI5003)** is hygroscopic in nature it is therefore essential to store it in a tightly packed container to prevent absorption of atmospheric moisture. In case moisture is absorbed **INNOKOAT MSK-CARE (A5dI5003)** can be dried at 40° C to 60° C for approximately six hours to reduce the moisture content.

#### **PACKING:**

**INNOKOAT MSK-CARE (A5dl5003)** is available in 25 kgs packing size in HDPE Carboys as secondary packing and LDPE bags as primary packing.
